



## **ANNOUNCEMENT FOR THE APPOINTMENT OF DATA PROTECTION OFFICER**

**SERVIER HELLAS PHARMACEUTICAL LTD.**, located at 7, Fragkoklissias str. - Maroussi, Attiki, (Tax Reg.No.095031152 – Tax Office Amaroussiou), **informs** all of you, employees and associates, that it has appointed **Ms. Athanassia Karagianni**, who already holds the Compliance Specialist position in our Company, as **Data Protection Officer (DPO)**, within the framework and in accordance with the **New European General Regulation on the Protection of Personal Data 2016/679 (GENERAL DATA PROTECTION REGULATION - GDPR)**, which will enter into force on **25/05/2018**.

### **POSITION AND COMPETENCES OF DPO ACCORDING TO GDPR**

- DPO is duly and timely involved in the decision-making process on all issues related to the protection of personal data and has all the necessary resources and means to perform her duties.
- DPO has authority to access all personal data collected and maintained by the Company and all processing activities carried out by the Company in its capacity as data controller and by any third party, as processor on behalf of the Company, as well as in all facilities of the relevant infrastructure and in all systems and technical means of information, in order to properly perform her duties.
- DPO does not receive orders to carry out her duties, is not dismissed or sanctioned because she has performed her duties. For her duties as a DPO, she reports directly to the General Manager of the Company.
- DPO is committed to confidentiality and confidentiality in the exercise of her duties in accordance with applicable law and GDPR.
- Data subjects may contact DPO for any matter relating to the processing of their personal data and the exercise of their rights.

### **DPO's DUTIES IN ACCORDANCE WITH GDPR**

DPO has the following duties:

- a) informs and advises the Company and/or data processors on behalf of the Company and the employees/associates processing data, of their obligations under the data protection legislation,
- b) monitors compliance with data protection legislation and the policies of the controller or processors in relation to the protection of personal data, including the assignment of competencies, awareness-raising and training of officials involved in processing operations and related controls,



- c) advises, when requested, on the impact assessment on data protection and monitor its implementation in accordance with Article 35 of GDPR,
- d) cooperates with the competent supervisory authority for the protection of personal data,
- e) acts as the point of contact with the competent supervisory authority for matters relating to personal data processing of, including prior consultation referred to in Article 36 of GDPR, and consults, as appropriate, on any other matter relating to processing activities, taking into account the nature, scope, context and processing purposes.
